Mass Care continues to support **7 shelters**, and **6 trailer expansion sites**. Recreation and Park's Summer Play LA program has begun at 46 Recreation sites. www.laparks.org

Recreation and Parks supported **Cooling Centers** Friday, July 31, 2020 and Saturday, August 1, 2020.

LAUSD continues to operate its 63 Grab and Go points of distribution with the same operational hours, 0800-1100, until August 14, 2020. They have served **333,161 meals** as of August 4, 2020 for an **overall total** of 50,396,230 meals served LAUSD's 2020-21 academic year for students will begin August 18, 2020 for virtual instruction.

LA Dept. of Transportation (LADOT) Parking Enforcement will be extending current relaxed parking enforcement regulations until August 16, 2020. LADOT has **RELAXED** enforcement for the following categories:

- Residential street sweeping.
- Expired registration on a vehicle.
- Overnight/Oversize parking districts.
- Peak/rush hour and gridlock zone parking restrictions.
- No ticket/tow for abandoned vehicles and oversized/overnight parking.
- Vehicles displaying recently expired permits within preferential parking districts will have a two-week grace period following the expiration to renew.
- No parking fine increases.
- Extended grace period for people dropping off or picking up.
- Immediate extensions on all deadlines for payments.
- LADOT will supply a temporary, print-at-home permit to residents within a preferential parking district who have renewed their permit but will not receive the new hangtag before their current permit expires.

BOC GENERAL UPDATES

During the COVID-19 (Novel Coronavirus), the Business Operations Center (BOC) has assisted the Emergency Operations Center (EOC) with providing critical items towards the response. The BOC continues conversation between our private sectors, Chamber of Commerce, Universities, NGO's and other agencies, and work with council office and Neighborhood Councils.

BOC UPDATES

- The Business Operation Center held a conference call with members of the Business Ambassadors Program and the Mayor's Office of Public Safety to discuss how the BOC can support the newly activated Business Ambassadors Program and what information the BOC can provide in response to inquiries from the business community about the program.
- Discussions with the Los Angeles Area Chamber of Commerce have begun to develop a webinar on business readiness for September, National Preparedness Month.
- BOC participated in a Telebriefing for Faith-Based and Community Organizations. Public Health officials fielded a variety of questions from participants including what settings to use face shields, singing and chanting restrictions, baptisms in outdoor services, disinfecting facilities and where to find supplies, how non-compliance of health orders is reported and addressed.
- Los Angeles County will be issuing fines to all businesses that are non-compliant. The start date has not been confirmed. Fines can range from \$100 for the first offense to \$500 and a 30-day permit suspension for multiple offenses. - Working with the LA Area Chamber to identify critical needs within the business community. BOC is also working with Chamber to identify critical technology needs of the small business community.
- Closely collaborating with Department of Public Health liaison to update the various public/private sectors on changes in public health orders, protocols and procedures.
- Working with the Public Information Officer and Information Technology Agency in developing a BOC website and virtual assistance center.
- Working with Public Information Officer to develop social media content for business readiness, response and recovery for sharing on the City's various platforms.
- BOC updated the Department's **Business Readiness** page with new content which includes: Resuming Business Toolkit Coronavirus Disease 2019; 7 Steps to a Disaster Resilient Workplace; and LAEDC's Guide to Planning for Business Operations After Earthquake. SECTOR/PARTNER UPDATES

- **Emergency Preparedness:** The City's Emergency Management Department has tools to prepare Angelinos for the next disaster. These tools are directed for the individual, their family, their neighborhood and event their pets. - **LA Regional Chamber**, along with LA County, developed the website [OneLA Regional Collaborative](#). The focus is a public-private partnership that transforms procurement regionally. This collaboration includes the City of Los Angeles Chief of Procurement. The Chamber is working with the State of California in receiving PPE's for small business. This includes receiving, warehousing and distribution to all those who are eligible. The team is working with the County of Los Angeles in designing "seal of approval" process that recognizes companies who are following County COVID-19 protocols in ensuring that their employees and customers are safe. - **The Salvation Army** has transitioned from coronavirus-related services into normal services. The Salvation Army's involvement with the Project Room Key will continue past July at least and locations within the California South Division are working on plans to reopen Corps Community. - **Houses of Worships:** The House of Worships are in a large need for Personal Protective Equipment for their individual organizations and churches.
- **Academics:** LAUSD announced that their schools will not open for the fall. Private/Religious/Charter school can apply for possible waivers with County of Los Angeles Department of Health once the health orders are relaxed.
